I had a hard time getting rid of the old table, so I took out the leaves and set it up in the nonfiction section and it has now become a feature table, it's a fall theme. Halloween went really well! This year the weather was great! We social distanced at all three tables, candy table, Bubble/craft table and book giveaway table. I lost count after 200. I had a huge donation of some more children's and adult books that I have cataloged; our donations of books are starting to pick up again. My patrons are starting to feel a little more comfortable about being in the library to check out material and use the computers. I am going to make a few changes in the children's area. Good afternoon. As of today, we are all well here in Hillman. We had Stacey the plumber, come in and fix our sump pump. He also checked our hot water heater, which is in need of cleaning. Our carpet in most of the building has cleaned by Mark the volunteer and looks much better. We had 11 screaming balloon activities picked up the first week of the new schedule. We have created a display table to feature the weekly activity along with corresponding books, hoping this will draw some attention. Halloween was a success...Robin, Pat Keith & I passed out books and candy outside the building. We had approx. 210 children, which is down a bit for us. Thanks again for your help! Stay well.

### Sheila from Atlantic reports:

Hello, October has been a good month here in Atlanta. Now that we no longer need appointments, our patron visits and circulation are on the rise. Circulation was 650 total items checked out in October (up from 568 in September). Patrons who signed in to either use the computers or to choose materials came in at 268 (up from 155 last month). If you add in the patrons who stopped just inside our door, we were just shy of 500 people for the month. We added 56 new items to our collections. Donations are down slightly but the books that are donated tend to be newer and more in demand. They also tend to be coming from our patrons who are not comfortable coming in yet; so they are buying the books they want to read and then sharing them with us. Halloween was busy. We had 180 children stop by for candy and books and it worked well to have it outside. This was up from last year. Unfortunately, we saw very limited mask use. A large percentage of the children were not from our area. The science and art projects are off to a slow start. The first project, the Screaming Balloons, we had 36 go out. For the second project I've paired the Native American Projects with a book display and colorful signs to catch everyone's attention as they come in the door. I'm hopeful that our numbers will increase as word gets out. Otherwise, we've our carpets cleaned; our porch light replaced, and will have an electrician look at what we can do to light up our big sign. Now that it's dark so early it will be nice for people driving by to know that we are a library. Thanks for all you do.
